Perhaps we could get used to moving and re-setting the cones after each event.

It also would not hurt to <u>also</u> get the "no trucks" image signs (in red if they have it), added to the two main entrances.

If we could afford more professional looking blockades, as Jeff points out, this would be ideal.

Just a quick note. If we are trying to put up barriers to keep people out of the church. We should really consider the purpose. If we feel that it is important and are wanting to spend money for sure we should get retractable automatic bollards so that when we have events they are down and then when we are done they go back up at specific arranged time and don't require people to engage it should be something that can be arranged much in advanced online as well as have a switch inside for ad hoc events.

It is a bother and a bit dangerous to have anything keeping our main entrance unavailable for people to use for events during the week as it is now with the cones. So definitely having a new option that is safer and more helpful would be better.

I completely understand to cost to the repair of the parking lot. This might cost the same but might save a new parking lot if we put a new one in.

Just some thoughts. Thanks for including us in the conversation. I'm all about making the church more inviting and something that is out of sight when we arrive would be great.

Hello All.

I wanted to give you a quick heads-up that we are actively exploring methods to deter unauthorized use of our main parking lot. I'm reaching out to you because you host regular events with invited guests.

While signage has been in place, it has unfortunately proven ineffective in discouraging misuse. We're now considering physical barriers or other controlled access solutions to better manage who is using the lot. At the same time, we're committed to ensuring that access remains smooth and welcoming for our invited guests, such as food pantry clients, pickleball and basketball players, and other authorized users.

We also value our role as a good neighbor, and when possible, we'd still like to have the option to accommodate truck drivers who may need a safe place to park during an emergency—unfortunately in some cases providing temporary access may not be an option.

So that you have an idea of why we are considering methods to restrict access of unauthorized use, below is a picture of the damage commercial trucks can cause to the lot.

Obviously on Sundays, there will be unrestricted access to the lot. We'll keep you updated as plans progress, and we welcome any input or questions you might have along the way.
